


## NOTICE OF MEETING

### FORT BEND COUNTY MUNICIPAL UTILITY DISTRICT NO. 187

3. Series 2019 Unlimited Tax Bonds, including:
  - a. preparation of Preliminary Official Statement and Official Notice of Sale;
  - b. authorize District engineer to request Texas Commission on Environmental Quality inspection of facilities; and
  - c. authorize tax assessor/collector to request Certificate of Assessed Value as of January 1 from the Appraisal District.
4. Review and update Eminent Domain Report to the Texas Comptroller.
5. Travel Reimbursement Guidelines and Director Expenses for the Association of Water Board Directors winter conference.
6. Financial and bookkeeping matters, including payment of bills, review of investments.
7. Tax assessment and collection matters, including delinquent tax collections, installment agreements, and payment of tax bills.
8. Operation of District facilities, including billings, repairs, and maintenance, including:
  - a. City of Richmond Surface Water Plant; and
  - b. amend Rate Order.
9. Report regarding development in and around the District.
10. Landscaping, park and District maintenance and repair matters, including:
  - a. construction contracts, pay estimates and permits, deeds, easements, consents to encroachment; and
  - b. update on hike and bike trail, including Master License Agreement for Hike and Bike Trail with CenterPoint.
11. Engineering matters, including repair and maintenance authorization, permits, deeds, easements, consents to encroachment, requests for service or utility commitment letters, drainage of sidewalk in CenterPoint easement, and update on bond application.
